**Sub : Last date for IEC Updation extended till 31.07.2021**

As you are aware, DGFT had issued Trade Notice No. 01/2021-22 dated April 29, 2021 regarding the mandatory updation of IEC (Importer – Exporter Code) details before 30.6.2021.

In this regard, the Council had sent a representation to the DGFT for an extension in the last date for IEC updation, on the basis of requests received from its members.

We are glad to inform you that DGFT has now extended the last date for IEC updation by one month i.e till 31.7.2021 vide Notification No. 11/2015-20 dated July 1, 2021, a copy of which is enclosed herewith [\(click here\)](#).

You are requested to please take note of the above and do the needful.

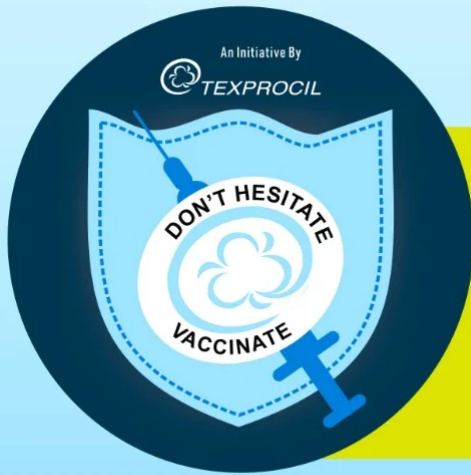
