<u>Sub : Sunset Review - Anti Dumping Duties on Elastomeric Filament Yarn</u> (<u>Spandex Yarn</u>)

Dear Member,

As you are aware, Government has imposed Definitive Anti-dumping duties on 'Elastomeric Filament Yarn' (popularly known as Spandex Yarn) originating or exported from China, South Korea, Taiwan and Vietnam vide Notification No. 15/2017-Customs (ADD) Date 03/05/2017 for a period of 5 years till 02.05.2022.

In this regard, the Government has now vide Notification dated June 30, 2021 initiated a Sunset Review (SSR) investigation to review whether there is a need for the continuation of the above Anti dumping duties and also to examine whether the expiry of existing anti-dumping duties are likely to lead to continuation or recurrence of dumping and injury to the Domestic Industry.

The period of investigation for the Sunset Review is January, 2020 to December, 2020 (12 months) and the injury investigation period will cover the periods 2017-18, 2018-19, 2019-20 and the period of investigation.
