Sub : Inviting responses from Members on proposed India-UK FTA

Dear Member,

This is to inform you that Trade Ministers of India and the UK have signed a 'Declaration' on the launch of the Enhanced Trade Partnership [ETP] announced by the Prime Ministers of both the countries on 4th May 2021. The ETP launch carries a bilateral commitment towards negotiation of a comprehensive Free Trade Agreement [FTA] to unlock the full potential of India-UK trade and commercial relationship.

With reference to the proposed India UK ETP, discussions are being held for understanding the level of Indian trade of non-agricultural goods with the UK from the point of view of TBT / NTB (Technical Barrier to Trade / Non-Tariff Barriers).

As part of the ETP, both sides are undertaking respective scoping, consultations and domestic processes and towards this endeavor, the Department of Commerce (DoC) is seeking views, comments and suggestions of the stakeholders concerned on the proposed FTA between India and the UK.

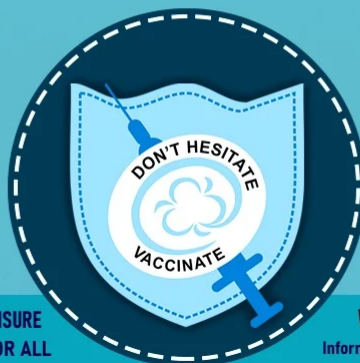
