Dear Member,

The Council has received a communication from the FT (Europe) Division of the Department of Commerce, Govt of India regarding discussions with the stakeholders on the proposed FTA between India and the UK.

The different negotiating teams formed for the purpose by the Ministry of Commerce are presently engaged with the Scoping and Contouring exercise for the respective tracks, in consultations with domestic stakeholders, which is planned to be completed by 31st July 2021.

Towards this aim, FT(Europe) Division and negotiating team under 'Trade in Goods' is presently engaged with domestic stakeholders and has had interactions on 6th, 7th and 9th July 2021 covering different HS chapters. During these interactions, it was informed to the stakeholders that a Questionnaire would be circulated to them for seeking their inputs w.r.t. different products covered under various HS chapters.

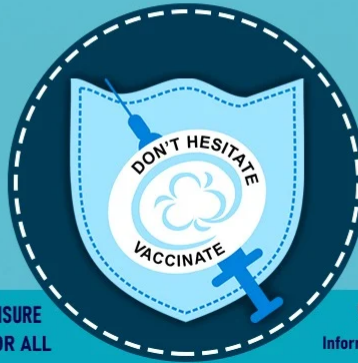
