DGFT has issued Notification No.26/2015-2020 dated 16/09/2021 according to which the last date for submitting applications under the MEIS, RoSCTL and ROSL schemes is 31.12.2021.

Further, as per the said Notification, the Validity of any Scrips issued under the FTP from 16/9/2021 will be 12 months from the date of issue.
