Sub : Relief in Average Export Obligation in terms of the Para 5.19 of Hand Book of Procedures (HBP) of FTP 2015-20

Dear Member,

DGFT has issued Policy Circular No.37/2015-20 dated 10/09/2021 to provide relief in the Average Export Obligation under the EPCG scheme for those products that has witnessed a decline in exports in 2019-20 as compared to 2018-19 and in 2020-21 as compared to 2019-20. A list of such products have been attached alongwith the Circular.

The Regional offices of DGFT will re-fix the Annual Average Export Obligations accordingly for EPCG Authorizations for the years 2019-20 and 2020-21.
