<u>Sub : Requesting details of specific cases of delay (or) held up export consignments to USA due to abnormal increase in freight rates</u>

Dear Member,

In its latest report on India's trade with USA, Department of Commerce of the Government of India has pointed out that export of Cotton Textiles fell short of target. Department of Commerce has requested that Indian Mission/Posts abroad and the Council may take necessary action to ensure growth in exports.

In this context, The Consulate General of India, Atlanta, USA would like to know any constraints on US side that the exporters may seek their help.

It has been observed that a large volume of goods are held at exporters/ warehouses mainly due to abnormal increase in freight rates and were asked by the importers in the USA to delay their shipments.

If you are facing such issues, kindly provide specific details, latest by 30th September 2021, about the cargo and the importers' coordinates so that Indian Missions in the USA can take it up with concerned importers suitably.
