An overview

The RODTEP scheme has been implemented w.e.f January 1, 2021. Also the RoSCTL scheme has been extended from January 1, 2021 to March 31, 2024. It is important that exporters fully understand the operational guidelines of these two schemes so that they can get the benefits smoothly and without delay.

Objective of the Webinar

The Council is continuously receiving queries from a large number of its members seeking clarifications on the operation of the RODTEP and RoSCTL schemes. The objective of the Webinar is to disseminate all the information related to these two schemes so that exporters follow the prescribed procedures properly and does not lose the benefits due to any mistake or error.

Webinar coverage

The focus of the Webinar will be FAQs. It will address all the queries which the Council has been receiving on a daily basis from the exporters.

The Webinar will cover the following:

- An overview of the RODTEP scheme.

- Operating Principle of the RODTEP scheme.
- Implementation of the RODTEP scheme on the Customs Automated System.
- How to create E-Scrips and Generate Scrips.
- How to transfer Scrips.
- Calculation and Processing of RODTEP claims (Retrospective cases w.e.f 1.1.2021 to 1.10.2021) .
- Calculation and Processing of RODTEP claims (Prospective cases w.e.f 1.10.2021).
- Scroll generation.
- Utilization of Scrips for duty payments.
- Ineligible categories of Exports under the RODTEP scheme.
- Implementation of the extended RoSCTL scheme.
- Applicability of GST on transfer of Scrips.

The Highlight of the Webinar will be the “Question & Answer Session” during which participants can seek clarifications / informations on various issues related to the RODTEP and RoSCTL schemes. All the queries will be addressed. Participants can also seek guidance on specific cases.
