Sub : Virtual B2B Meeting with Embassy of India, Baku and Azerbaijani importers

Dear Member,

As you may be aware, under the able leadership of the Hon'ble Prime Minister Shri Narendra Modiji, the Department of Commerce has set an ambitious but achievable export merchandise target of US\$ 400 billion for FY 2021-22.

Considering the above and in an effort to boost the export of cotton textiles to Azerbaijan, the Embassy of India in Baku, Azerbaijan has contacted the Council and proposed a virtual BSM meeting between Indian textile exporters and Azerbaijani importers on 11th November at 1.30 pm (India Time).

According to Azerbaijani statistics, Azerbaijan imported goods worth US \$ 101 million in 2020 under 2-digit HS Code 52, 59 and 63 and their principal sources were China, Russia, Ukraine, Turkey etc. There is however scope to increase our market share in the Azerbaijan market with the guidance and support of the Indian Mission.

In order to take this forward, the Indian Mission has requested the Council to submit the names and profiles including products of member companies who are interested in exploring the Azerbaijani market. Based on the profile of the interested Indian suppliers the Indian Mission will find matching companies in Azerbaijan who wish to partner with Indian suppliers.
