Sub : Extension of time limit for submitting UID applications under the ATUF Scheme

Dear Member,

The office of the Textile Commissioner issued Circular dated 10.11.2021 to provide relaxation in the time line for submission of UID applications by the Unit and the Banks.

As per the Circular, in case, the cut off dates for the submission of UID applications falls between March 23, 2021 and October 22, 2021 and the Units and Banks could not submit their UID applications due to the lock down on account of the second wave of Covid - 19, the UID applications can now be submitted on the i-TUFS portal till January 20, 2022.

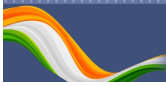

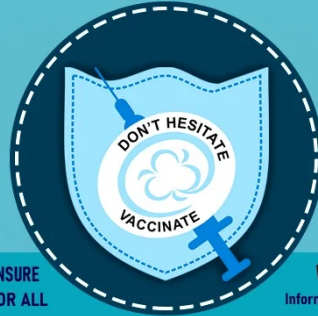
