The office of the Textile Commissioner has issued Public Notice dated 10.11.2021 to provide condonation of delay in submitting UID applications in certain cases. The condonation has been granted based on decision taken in the 5th Meeting of the Inter Ministerial Steering Committee (IMSC) held on 22.10.2021.

Accordingly, units can now submit their UID applications on the i-TUFS Portal on or before January 19, 2022.
