Sub : Revised GST Rates on Textiles & Clothing w.e.f .01.01.2022

Dear Member,

CBIC has issued Notification No. 14/2021-Central Tax (Rate) dated 18.11.2021 to increase the GST rates on certain textiles & clothing products from 5% to 12%.

GST rates have been increased on Cotton Fabrics (Both Woven & Knitted), MMF Yarns, Fabrics of MMF, Made ups & Garments of value upto Rs.1000 per pc. The GST rate on Cotton Yarn remain unchanged at 5% .

The revised rates are effective from January 1, 2022.
