<u>Trade Data</u>

In the year 2020, EU (27) imported US\$ 130.77 billion worth of T & C from the world, of which, import from India was US\$ 5.54 billion, accounting for 4.24% market share.

European Union (EU 27) as a combined market is the largest importer of Textiles & Clothing (T&C) from India, accounting for 18.66% of total export of T&C from India during 2020.

Considering the higher spending capacity in EU 27 countries, as a block, it is the single largest market for the Indian export of T&C products.

However only 5.54 % of total import of T&C into EU was from India thereby offering scope for increasing market share by undertaking suitable marketing activities, such as participation in this established event to meet major importers in EU.

Corner Booth Premium

Actual fee charged by the organizers will be applicable for corner booth premium i.e. discount / subsidy is not applicable for corner booth premium. Due to availability of limited number of corner booths, allocation will be done by Messe Frankfurt, Paris, after considering various aspects as per their own guidelines.

Companies interested in Corner Booth are required to send a separate cheque to the Council along with Application. In case Corner booth is not allocated to interested companies, their cheque will be returned.

MAI / MDA Funding

In accordance with the recent amendments in the MAI / MDA guidelines and conditional approval from the Ministry of Commerce, subsidized fee is available for maximum of 25 participants through the Council subject to fulfillment of criteria prescribed in the MAI scheme of Govt.of India. Application will be treated on Firstcome-First Served basis due to limited availability of funds under the scheme subject to the following important criteria:

1. Those exporters who have already availed subsidized fee under MAI scheme for 3 or more times (through any Export Promotion Councils) in any particular event, are not eligible to get refund under MAI scheme for participation in that particular event.

2. An exporter can avail MAI benefit for participation in a maximum of 3 approved MAI events in a financial year.

3. In the event of participation of at least 25 exporters (for the 1st or 2nd or 3rd time), applicable MAI benefit will be passed on to eligible exhibitors after finalisation of the participation.

4. Further, the participants who have completed 12 months of membership with the Council and having exports of FOB value upto Rs.50 crore in preceding year will be entitled for air fare reimbursement for the travel of Regular Director / Partner / Proprietor or a regular officer of the company in senior managerial position. The reimbursement will be upto Rs.75,000/- (economy class air travel) or actual (whichever is less) or a lumpsum amount subject to the final approval received from the Ministry.

VAT

As per new guidelines, certain category of exhibitors are exempted from VAT. In case your Company does not qualify for VAT exemption, equivalent amount need to be paid by you on getting final invoice from the organizers.

GUIDELINES FOR THE ALLOTMENT OF BOOTHS:

Participants who pay the full participation fee in time would be considered for allotment of booths.

- 1. Due to limited availability of booths applications will be considered on First Come First Served basis ONLY
- 2. The decision of Chairman / ED, TEXPROCIL would be final in case of any confusion / dispute.
- 3. No change in the booths, once allotted would be entertained under any circumstances.

CANCELLATION

In case of cancellation / withdrawal of participation by Members full participation fees will be forfeited.
