Sub : E-scrips under the RODTEP and RoSCTL schemes

Dear Member,

As you are aware, the RODTEP scheme has been implemented w.e.f January 1, 2021. The RoSCTL Scheme has also been extended for another three years till March 31, 2024.

In this regard, the Council has been receiving queries from the members regarding the implementation of the RODTEP and RoSCTL schemes by the Customs Authorities.

Based on these queries, the following are the clarifications:

- The online system for the generation and transfer of E-Scrips are fully operational at the Customs. E-Scrips can be generated and transferred.
- The system also allows payment of Basic Customs Duty on imports.

Advisory

In the case of imports, please file the Bill of Entry directly on the ICEGATE Portal. Please advise your CHAs accordingly. Also, please advise the CHAs not to file the Bill of Entry through the online system created by them for the purpose of filing the Bill of Entry.
