As you are aware, Japan is the third largest market for Textile & Apparel in the world growing at a CAGR of 1.23% during pre-covid (2015-19) periods. Though India's export to Japan market has been witnessing steady growth during the past five years, the volume of exports constitute only 1% of the Japanese market.

In order to enhance exports to the Japan market and as a first step to suggest doable ideas, the Textiles Committee proposes to organize a virtual meet with the key exporters of T&A in India. The major issues of discussions will be:
