Sub : Imposition of definitive anti-dumping duties by Peru on import of Polyester / Cotton blended plain weave fabrics from China

Dear Member,

The Commission on Dumping, Subsidies and Elimination of Non-tariff Trade Barriers (CDB), vide Resolution No. 273-2021/CDB-INDECOPI, decided to impose definitive antidumping duties on import of plain weave fabrics made exclusively with polyester and cotton staple fibres from China.

The resolution states that the Imposition of definitive antidumping duties of US\$ 2.08 per kilogram on imports of plain weave fabrics made exclusively with polyester and cotton staple fibres, raw, white, bleached or dyed in a single colour, with a width of up to 1.80 meter, and weight between 80gr/m² and 130 gr/ m², for whichever use, from the People's Republic of China, for five (5) years, since the entry into force of the resolution (the following day of its publication on the official gazette i.e. 20 November, 2021).

The tariff lines included in this resolution are the following: 5512.11.00.00; 5512.19.00.00; 5513.11.00.00 and 5513.21.00.00. Data analysis shows that, China was the main supplier of products under HS Codes 551211 and 551219, the third largest supplier of goods under HS Code 551311 and fourth largest supplier of goods under HS code 551321 during the period from 2017 to 2020. [Click here for data sheet.](#)

Market share of India in this products is almost negligible thereby offering a greater scope for Indian exporters to increase export of polyester / cotton blended fabrics to Peru. Members may take advantage of this opportunity.
