Sub : Amendments in HSN Customs Tariff from 1st January 2022 and its alignments with HS 2022

Dear Member,

The World Customs Organization has announced the seventh edition of HSN – HS 2022, effective from 1st January 2022.

The new edition of the Harmonised System (HS) has 351 amendments at the 6-digit level covering a wide range of products and services. Since India follows the 8-digit classification system, CBIC has facilitated the co-relation HS 2021 and HS 2022 at the 8-digit level for ease of understanding of the Exporters and Importers.

CBIC issued a letter vide D.O.F. No 524/11/2021-STO (TU) dated 20th December 2021. Attached ([click here](#)) is the Guidance Document containing Annexure I (Coding details) & Annexure II (HS Codes of both HS 2021 & HS 2022 with co-relation code) that enables clear understanding of the revisions made at the 8-digit level between the two years.

Member Exporters are requested to review the Guidance document and get their HS Codes aligned as per HS 2022, for all export-import transactions beginning 1st January 2022 since India is a party to the HS Convention and necessary changes have been carried accordingly vide the Fifth Schedule to the Finance Act, 2021.

The document is only a guide to enable easy and quick understanding of the revisions between HS 2021 and HS 2022 and has no legal binding in case of any errors or omissions.


