#### <u>Trade Data</u>

- Thailand imported USD 4.35 billion of Textile & clothing in the year 2020 (Jan-Dec)
- India is the number two supplier of cotton yarn to Thailand. India exported USD 30.57 million with a share of 28.62%
- India is the third ranked supplier for raw cotton to Thailand. India exported USD 10.62 million with a share of 4.64%
- India also exported fabrics worth USD 37.65 million to Brazil in 2020 (Jan-Dec)
- India has good potential to increase yarn, fabric & madeup exports in this market


