<u>Sub: Registration of Existing Enterprises as MSMEs</u>

Dear Member,

As you are aware, the Ministry of MSMEs vide Notification dated 26/6/2020 had revised the criteria for classifying the enterprises as Micro, Small & Medium units

As per the said Notification, all existing enterprises registered prior to 30th June, 2020 under EM-Part-II or UAM shall continue to be valid for a period of upto 31st March, 2021.

The Ministry of MSMEs has now issued Notification dated 19th January, 2022 according to which "Existing Enterprises registered prior to 30th June, 2020 shall continue to be valid till 31st March, 2022. These units are, therefore, eligible for all the benefits that are being extended to the MSMEs till March 31, 2022.
