Sub : Last Date for filing applications for RoSCTL is 28.02.2022

Dear Member,

As you are aware, the applications for rebate under ROSCTL Scheme for exports made between 07.03.2019 to 31.12.2020 are required to be made at the DGFT portal under provisions as under Notification no. 58 dated 29.01.2020.

DGFT has extended the last date for filing applications for duty credit scrips under the MEIS, RoSCTL and RoSL schemes from 31.01.2022 to 28.02.2022 as per DGFT Notification No.53/2015-2020 dated 1/2/2022.

Now we have been informed by the DGFT that a significant number of exporters have still not submitted their online claims under ROSCTL and many ROSCTL shipping bills remain unutilized and unclaimed.

The Office of DGFT has published the names of exporters appearing in the system whose unclaimed shipping bills are reflected in electronic database at the Office of DGFT. A list of such exporters is enclosed herewith. ([click here](#)).

You are requested to kindly take note and submit claims (if not already done) within the deadline date which is 28.02.2022.

Please note that after 28.02.2022, no further applications would be allowed to be filed and even the provision to submit applications at a later date with Late Cuts would not be available.
