Dear Member,

We have been informed by the Embassy of India in Guatemala that they propose to participate at the Apparel Sourcing Show in Guatemala City by taking a 9 sq mt stall. The Show is to be held from May 24-26, 2022.

We request Members to take advantage of this opportunity to showcase their cotton textile products in this market by sending samples of their products along with their company profiles / brochures / visiting cards.

Each of the samples should be labeled properly mentioning complete specs with code numbers and trade enquiries received will be accordingly conveyed to respective Members contributing samples.

Interested members may send their Samples (on non-returnable basis) as per the following:

1. Baby Cones of Yarns (max 10 cones)
2. Hanger swatches of 30 cm width X 1 mtr length (max 20 swatches)
3. Swatch folders

To maintain uniformity in display at the booth, the Council reserves the right to reject samples of irregular sizes.

Fees for display of samples:

Rs. 10,000/- + GST 18% = Rs. 11,800/- per company.

Members interested in getting their Samples displayed are requested to send their samples to the Texprocil office in Mumbai and make the payment by multicurrency cheque / demand draft favoring 'The Cotton Textiles Export Promotion Council' on or before 10th March 2022.
