Sub: Interest Equalization Scheme

Dear Member,

RBI has issued Notification dated March 8, 2022 to extend the Interest Equalization scheme for Pre-Shipment and Post-Shipment Rupee Export Credit till March 31, 2024 or till further review, whichever is earlier.

Also, the rate of interest subsidy has been revised under the scheme. It will now be 3 per cent for all products exported by manufacturer exporters and 2 per cent for manufacturer exporters and merchant exporters exporting products covered under 410 notified HS lines.

Further, the scheme has been extended with retrospective effect from 1/10/2021.
