Sub : Inviting participation at the Virtual Buyer Seller Meet (BSM) with importers from the Dominican Republic on 18th May 2022

Dear Member,

The Council along with Embassy of India in Santo Domingo and ADITEX, the leading textiles trade body in the Dominican Republic is organising a virtual BSM between Indian exporters and importers from the Dominican Republic on Wednesday 18<sup>th</sup> May 2022, from 8 p.m. onwards (India Time)/10.30 a.m. (Dominican Republic time).

The online Buyer Seller Meet (BSM) is being organised with support and guidance from the Embassy of India in Santo Domingo and the management of ADITEX. This is a focused BSM where member importers of the largest textile trade body (ADITEX) who are sourcing cotton yarn and fabric as well as made-ups will be participating in the B2B session.

Highlights of the market for Cotton Textiles in Dominican Republic

- The Dominican Republic imported USD 544.63 million of Cotton Textile Products in the year 2021-22.
- Imports of cotton yarn was 36% of the total, imports of fabric were 16% of the total and the balance 48% was imports of made-ups because of the demand for masks. In the previous years, imports of yarn constituted 50% of the total imports, while fabric and made-ups constituted the balance 50%.
- Dominican Republic is the 11<sup>th</sup> largest importer of yarn in the world and is also among the top 50 countries importing made-ups.
- The top HS Lines of imports of yarns are 520523, 520710, 520511
- The top HS Lines of imports of fabrics are 520942, 520919, 520819
- The top HS Lines of imports of made-ups are 630710, 630210
- India's market share in all three categories is less than 5% and hence there exists a large potential for Indian exporters.

Participation Fee: Rs. 10000 +GST 18% = Rs. 11800/-

Being a virtual B2B meet, participation is limited and member participation shall be confirmed on a First-Come-First Served basis and receipt of full participation fees.

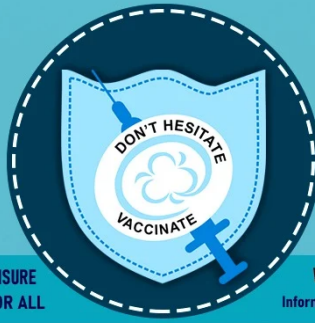
