The Cotton Textiles Export Promotion Council (TEXPROCIL) is organizing an India Pavilion in the 20th Vietnam Int'l Textile & Garment Industry (VTG) exhibition from 21st – 24th September 2022 at the Saigon Exhibition & Convention Center (SECC), Ho Chi Minh City, Vietnam.

VTG is organized by Ministry of Industry & Trade Vietnam National Trade Fair & Advertising Joint Stock Company (VINEXAD) and sponsored by VITAS- Vietnam Textile & Apparel Association, AGTEK – Association of Garment – Textile and VCOSA – Vietnam Cotton & Spinning Association. _

<u>Vietnam Textile & Clothing Industry</u>

Vietnam is among top 5 nations in the world in exporting garments and hence offers very good opportunity for increasing exports of yarn & fabrics.

In 2021, Vietnam imported about USD 29.45 bn worth of textile and clothing of which approximately USD 26.04 bn was in textiles. India's share in the textiles imports was just USD 647.2 mn. In cotton textiles, Vietnam imported almost USD 8.18 bn of which India's share was just 2.75% amounting to USD 225 mn. Import of cotton fabrics from the World contributed the highest share within the cotton textiles import basket with USD 6.69 bn and India ranked 12th with USD 22.93 mn. There is good potential for yarn as well as fabrics in this market.

Subsidized Participation fees for 9 sq. meters booth is Rs. 1,40,000/-

Each 9 sq mtr. of exhibit space includes * Fascia * 1 power point socket * Carpet * 1 round table * 3 folding chairs * 1 reception desk * 1 waste basket * 3 spotlights 100W * 2 shelves (yarn exhibitors) OR 2 hanging rails (fabric exhibitors).

MAI funding

In accordance with the recent amendments in the MAI / MDA guidelines and conditional approval from the Ministry of Commerce, subsidized fee is available for maximum of 10 participants through the Council subject to fulfilment of criteria prescribed in the MAI scheme of Govt. of India. Application will be treated on First-come-First Served basis due to limited availability of funds under the scheme subject to the following important criteria:

- 1. Those exporters who have already availed subsidized fee under MAI scheme for 3 or more times including past participation (through any Export Promotion Council) in this event are not eligible to get subsidy under MAI scheme for participation in this edition of VTG, Vietnam.
- 2. An exporter can avail MAI benefit for participation in a maximum of 3 approved MAI events in a financial year.

Further, the participants who have completed 12 months of membership with the Council and having exports of FOB value upto Rs. 50 crore in preceding year will be entitled for air fare reimbursement for the travel of Regular Director / Partner / Proprietor or a regular officer of the company on senior managerial position. However Member with zero export in the last financial year will not be eligible. The reimbursement will be upto Rs.75,000/- (economy class air travel)

<u>Cancellation / withdrawal policy:</u>

In case of cancellation / withdrawal of participation by Members, full participation

fees will be forfeited.

The participation charges are refundable only in case of cancellation of trade fair by the fair organizer or due to COVID19 travel restrictions, if any.

Interested members are requested to send their confirmation to the Council along with the filled application form (click here for form) and the full participation fee by multicity Cheque / DD to be drawn in favour of "The Cotton Textiles Export Promotion Council" to the Texprocil Head Office located at 5th Floor, Engineering Centre, 9, Mathew Road, Mumbai – 400004 not later than 29th July 2022.

<u>Participation in the exhibition will be confirmed only on receipt of completed application form and full payment towards the booth charges.</u>
