<u>Sub : Reimbursement of 75% of the RCMC charges paid to TEXPROCIL under the International Cooperation Scheme of the Ministry of MSME, Govt of India – Capacity Building of First Time Exporters (CBFTE)</u>

Dear Member,

This is to inform that the Ministry of Micro, Small & Medium Enterprises (MSME), Government of India, is implementing International Cooperation (IC) Scheme with the objective to provide the necessary support to MSMEs and increase their pace with which they are embedded in the global value chains. One of the components of IC scheme includes the reimbursement of various costs involved in export of goods and services to MSE exporters.

In this regard, TEXPROCIL has signed a MoU with the Ministry of MSME on September 20, 2022 to help the Micro & Small Enterprises (MSEs) for reimbursement 75% of the RCMC charges paid by the first time exporter in the same financial year.

Following are the eligibility conditions to claim the benefit by the first time MSE Exporter on export shipment:

- 1. MSE exporter should have a valid Udyam Registration Certificate
- 2. Importer-Exporter Code (IEC) must not be older than 3 years on the date of export shipment

Documents required for availing the above benefit under CBFTE of the IC scheme are as under:

- 1. IEC code (not more than 3 years old on the date of export shipment)
- 2. RCMC fee receipt
- 3. Proof of Export carried out in the same financial year for which RCMC is claimed
- 4. Claim form for Sub-Component-II: Capacity Building for First Time MSE Exporter
- Annexure-K as prescribed by the Ministry (<u>Click here for the Claim form</u>) duly filled in, signed and stamped by the MSE member

5. Application Form for RCMC as per Form ANF-2C, prescribed by the DGFT – This form should be of the same or prior date, of your submission of online application in the DGFT's portal (Click here for Form ANF-2C)

TEXPROCIL will apply for the financial assistance claim on behalf of MSEs with the above documents received from our MSE members. Grants under the scheme will be released to TEXPROCIL on reimbursement basis on submission of the claim. The amount received from the Ministry of MSME, will then be transferred to the concerned MSE members. Please note that the reimbursement will be made subsequent to the receipt of grant from the Ministry of MSME.

Micro and Small Enterprises (MSEs) exporters enrolled with TEXPROCIL (who are the first time exporter) on or after 20th September, 2022 are requested to kindly claim the benefit under the above scheme.
