Sub : Sunset of PCS 1x and Go-Live of National Logistics Portal – Marine.(NLP-M).

Dear Member,

The Council is in receipt of a communication from the Traffic Manager, Syama Prasad Mookerjee Port, Kolkata informing about the new portal i.e. National Logistics Portal- Marine (NLP-M).

In line with the ongoing efforts towards 'go-live' of NLP-M, we would like to inform you that the Port Community System (PCS) and a few modules of NLP-M platform (<https://nlpmarine.gov.in/>) are targeted to be released on 5th December, 2022.

As you may be aware, PCS is a National Single Window that links individual seaports and all supply chain actors. This unique platform automates data and knowledge real-time sharing and allows better interaction management within the network.

With a shift to the new portal (NLP-M), the existing PCS 1x platform will be shut down and no longer be available from 02.12.2022 (22:00 hours). The break in operations between the shutdown of PCS1x and partial go-live of NLP-M is required for migration of data and user information.

The Indian Ports Association (IPA) has requested the trade users to continue their operations on NLP-M, as mentioned below-

- To use the PCS functionality on the new NLP-M platform.
- To send comments/suggestions for further improvements to the Syama Prasad Mookerjee Port, Kolkata.
- To log in to the new system, the users may use their existing PCS 1x credentials or contact IPA for login credentials at support.ipcs@nic.in or Tel.: 011-24369125 / 011-24360105 and 1800-11-5055.
