Dear Member,

As you may be aware, CBIC had earlier issued Notification No.58/2021-Customs (N.T.) dated 1.7.2021 ([copy enclosed](#)) had notified 32 countries for Agreement or Arrangement on Cooperation and Mutual Administrative Assistance (CMAA) in Customs matters subject to Provisions of Reciprocal arrangement for exchange of information to facilitate trade under Section 151B of the Customs Act, 1962.
