Sub : Special Drive conducted by RA (Mumbai) to expedite the process of Redemption / EODC of Advance Authorisation and EPCG Schemes

Dear Member,

The Council has received a communication from the O/o Addl. DGFT (Regional Authority), Mumbai on the above subject. In this regard, O/o Addl. DGFT (RA) has issued a Trade Notice No. 3/2022-23 dated 23rd January, 2023 ([copy enclosed](#)).

We would like to inform you that –

1) RA, Mumbai has re-structured and rationalized Sections in November, 2022 to enable faster processing of applications of Redemption/ Export Obligation Discharge Certificate (EODC) for Advance Authorizations (AA) and Export Promotion Capital Goods (EPCG) Schemes.

2) The provisions of FTP and HBP which outline the necessary compliances required for getting the Redemption/EODC of any Advance Authorizations (AA) and Export Promotion Capital Goods (EPCG) Schemes are readily available at the portal ([www.dgft.gov.in](http://www.dgft.gov.in)).

3) However, analysis of the applications made has revealed that certain applications lack the proper documents required for Redemption/ EODC leading to issuance of Deficiency Letters thereby resulting in delayed processing and issuance of Redemption/ EODC.

4) Scheme-wise common shortcomings have been identified by RA, Mumbai, and the same can be accessed by referring to Annexure-A for Advance Authorisation ([enclosed](#)) and Annexure-B for EPCG Authorization ([enclosed](#)).

Members may kindly take a note of the above and rectify the shortcomings to expedite the processing of Redemption/ EODC cases at the earliest.
