Sub : Revised Membership Subscription Fee for FY 2023-2024

Dear Member,

We take this opportunity to thank all our members for their continued support to TEXPROCIL which has helped to effectively promote exports of cotton textiles from India to over 150 countries worldwide. The timely remittance of Membership fees by our member exporters has motivated the Council to serve its members by exploring new markets, undertaking policy advocacy, and disseminating timely information.

The present membership fee being charged by the Council has not been increased during the last six (6) years while the inflation has increased many fold during this period thereby increasing costs all around.

Keeping in view these facts, it has become necessary to increase the membership fee of the Council also so that we may be able to sustain and enhance the quality of the services delivered to the members. Considering this, the committee of Administration of the Council at its meeting held on 03.04.2023, has decided to increase the annual membership fee w.e.f. 1st April 2023.

The revised Annual Renewal Subscription charges are as follows:

1) Registered Textile Exporter : Rs. 8,000/- + 18% GST = Rs. 9,440/-

2) Member Exporter (with voting rights) : Rs. 14,000/- + 18% GST = Rs. 16,520/-

REGISTRATION FEES FOR NEW EXPORTERS:

- 1) Member (with Voting Right) (including Rs.6000/- as Entrance Fee): Rs. 20,000/- + 18% GST = Rs. 23,600/-
- 2) Registered Textile Exporter (including Rs.3000/- as Entrance Fee): Rs. 11,000/- + 18% GST = Rs. 12,980/-

Please note that this will not be applicable to members who have already paid the renewal subscription for the year 2023-2024 on or before 31.03.2023.

As per the DGFT Trade Notice No.35/2021-2022 dated 24/02/2022, it is mandatory for all exporters to file registration/renewal/ amendment of RCMC through the e-RCMC Module on DGFT Portal <u>www.dgft.gov.in</u>

Accordingly, the process of 'Renewal of RCMC' for the year 2023-2024 can be done at the DGFT portal and pay the renewal fees mentioned above in the portal.

Steps for Renewal of Membership (Renewal of e-RCMC):

- -- Go to DGFT Website https://www.dgft.gov.in
- -- Click on the Login button and log in by using your username and password
- -- Go to Services > e-RCMC > Renewal of RCMC
- -- Complete the details in each tab and go ahead by pressing "Save and Next"
- -- At the end, the application needs to be signed digitally by DSC or Aadhar e-sign.

-- After signing of the application, the payment of renewal subscription needs to be done and click on 'Submit' to submit the application
