Sub: CBIC issues notifications related to Central Tax dated 31.7.2023

Dear Member,

CBIC has issued the following notifications related to Central Tax dated 31.7.2023

(1) Notification No.27/2023-Central Tax dated 31.7.2023 – CBIC notifies the provisions of section 1 of the Finance Act, 2021 (13 of 2021) w.e.f 1st October, 2023.

(2) Notification No.28/2023-Central Tax dated 31.7.2023 – CBIC notifies sections 137 to 162 of the Finance Act, 2023

(3) Notification No.30/2023-Central Tax dated 31.7.2023 – CBIC notifies special procedure to be followed by a registered person engaged in manufacturing of certain goods. This notification outlines requirements related to packing machines, records maintenance, and monthly statements.

(4) Notification No.31/2023-Central Tax dated 31.7.2023 – CBIC amends Notification No.27/2022 dated 26.12.2022. In the said notification, after the words, "State of Gujarat", the words "and the State of Puducherry" shall be inserted.

(5) Notification No.32/2023-Central Tax dated 31.7.2023 – CBIC exempts the registered person whose aggregate turnover in the F.Y. 2022-23 is up to Rs. 2 crores, from filing annual return for the said F.Y.

(6) Notification No.33/2023-Central Tax dated 31.7.2023 – CBIC notifies "Account Aggregator" as the systems with which information may be shared by the common portal under section 158A of the CGST Act, 2017.

(7) Notification No.34/2023-Central Tax dated 31.7.2023 - CBIC waives the requirement of mandatory registration under section 24(ix) of CGST Act for person supplying goods through E-Commerce Operators (ECOs), subject to certain conditions.
