Sub: Amnesty Scheme for One Time Settlement of default in export obligation by Advance and EPCG Authorisation holders

Dear Member,

JNCH has issued Public Notice No.76/2023 dated 5.9.2023 ([copy enclosed](#)) on the above subject.

Kind attention of Importers, Exporters and Custom House Brokers is drawn to DGFT Public Notice Nos.02/2023 dated 1.4.2023 and 07/2023 dated 18.4.2023 and Public Notice No.47 dated 25.5.2023 of JNCH. The deadline for registration for availing 'Amnesty Scheme for one time settlement of default in export obligation by Advance / EPCG Authorisation holders has been extended to 31.12.2023 and the date of payment of duty and interest has been extended to 31.3.2024.

Following procedures have been prescribed by JNCH for importers availing the Amnesty Scheme:

- 1) A proof of registration under 'Amesty Scheme' or a Deficiency Letter issued by DGFT indicating the payment to be made.
- 2) Installation Certificate, wherever required.
- 3) A declaration as given in Annexure at Page 2 of JNCH Public Notice No.76/2023 dated 5.9.2023. Those applicants who have not submitted the declaration in past should submit the same to Export Promotion Schemes Monitoring and Management Cell (EPSMMC), immediately.
- 4) Copy of Show Cause Notice (SCN) / O in O (Order in Original) of Adjudicating Authority/ Order of Appellate Authority, wherever applicable.

On receiving the above documents, the concerned officer from EPSMMC shall process the application in the original file available with EPSMMC to avoid duplication of files for same authorisations and for payment of duty and interest.

JNCH has advised the importers who were unable to meet their Export Obligations under Advance / EPCG Authorisations to avail the 'Amnesty Scheme' and regularise the default in Export Obligations.

Members may kindly make a note of the above procedures and do the needful as advised by JNCH.
