<u>Sub: Procedure for revalidation / new registration of Self-Sealing Permission in</u> <u>EDI system by Factory Stuffing Permission (FSP) Cell for Electronic sealing of</u> <u>containerized cargo at factory or warehouse premises</u>

Dear Member,

JNCH has issued Public Notice No.94/2023 dated 20.10.2023 (<u>copy enclosed</u>) on the above subject.

As you may be aware, since the validity of registration of Self-Sealing Permission is ending on 31.12.2023, JNCH has received representations from Exporters, Custom Brokers and Stakeholders requesting for extension of validity of registration for Self-Sealing Permission beyond 31.12.2023.

As a facilitation measure and Ease of doing Business, JNCH has now decided that –

--- Permission for factory stuffed containers for exporters already registered with EDI, JNCH and valid upto 31.12.2023 will be extended for <u>5 years upto 31.12.2028 for</u> <u>Manufacturer Exporters</u> and for <u>3 years upto 31.12.2026 for Merchant Exporters</u>, subject to submission of documents.

-- Cases where the validity mentioned in self-sealing permission issued by Jurisdictional Commissionerate is less than the aforementioned extended period - <u>Registration will be done only upto the cut-off date mentioned in self-sealing permission.</u>

-- Exporters whose self-sealing permission is already registered in EDI system (JNCH) and valid till 31.12.2023 shall submit the following documents by 31.12.2023 for revalidation of their registration of self-sealing permission to avail extension of their validity of registration.

i. Request Letter from the exporter.

ii. Permission/Registration copy issued by FSP Cell, JNCH & self-certified copy of jurisdictional Self-sealing/factory stuffing permission.

iii. Authorization Letter from the Exporter if the documents are submitted by a representative of a Custom Broker.

iv. Self-certified copy of valid IEC/PAN/GSTN Registration No.

v. Specimen signature with photograph of Authorized Signature duly attested by Director/Partner/Proprietor.

vi. Exporter's declaration of Previous cases, SCNs etc.

-- Request for registration for Self-sealing permission along with the aforesaid documents may be sent to JNCH in person or through email <u>(fspcell-jnch@gov.in).</u>

-- For first time registration of Self-sealing permission at JNCH, <u>the procedure to be</u> <u>followed by exporter for such registration shall remain same as mentioned in JNCH</u> <u>Public Notice No. 32/2018 dated 7.3.2018 until further orders.</u>

-- Exporters availing this facility of Self-sealing of export cargo with RFID/e-Seals are required to mandatorily file the Customs Inland Manifest for e-Seal Cargo (CIM-ES) electronically with Customs. Message has already been enabled for filing either by the exporter directly or through the Customs Broker. The message structure is available on ICEGATE Portal (<u>https://icegate.gov.in/Download/ES_MG_Volume1.1_060620.docx</u>) for ready reference.

-- Exporters who are under self-sealing permission/registration need to seek permission for any update/amendment to the original permission/registration viz

(i) Change of Premises

(ii) Change in Authorized Signatory

(iii) Amendments in ROC etc.

The same has been approved by the competent authority
