During the G20 Summit that was held in Delhi on September 9-10, 2023, the G20 Leaders adopted the G20 New Delhi Leaders' Declaration (NDLD) and one of the key themes of the NDLD was actions towards achieving Strong, Sustainable, Balanced and Inclusive Growth (SSBIG). Under this theme, the NDLD reflects on the key challenges confronting the global economy and provides policy guidance to address them.

As a follow up action on the implementation of the G20 NDLD deliverables and outcomes, a G20 Webinar in hybrid format has been scheduled on 6th November 2023 from 3:00 PM to 6:30 PM in Chanakya Hall, Sushma Swaraj Bhawan, New Delhi. The High-Level Inaugural Session from 03:00-03:30 PM will be addressed by Hon'ble Finance Minister, Govt of India. This will be followed by the three panel discussions of one hour each on the identified themes: "Unlocking Trade for Growth", "Preparing for the Future of Work" and "Advancing Financial Inclusion." The issue 'Unlocking Trade for Growth' which is being coordinated by the Department of Commerce will be held during 03:30 PM -04:30 PM.

Accordingly, you are invited to attend the proposed G20 webinar as it will be a unique opportunity to gain insights on the G20 process and deliberate on key initiatives on connecting Indian MSMEs to export markets while overcoming barriers imposed by inadequate access to information. Prominent academicians, industry representatives, think tanks, policymakers, international organizations, etc. are likely to be present in person during the event.
