Sub: Only few days left to file applications for Advance Authorization and EPCG Scheme under Amnesty Scheme: Last date 31st December 2023

Dear Member,

We would like to inform you that the O/o DGFT RA, Mumbai had convened a meeting with EPCs on 18.12.2023 to discuss about the Amnesty Scheme.

During the meeting, O/o DGFT RA – Mumbai has informed the EPCs that –

- Amnesty scheme is a welcome relief for businesses to clear their previously pending filings without the burden of late fees, hefty penalties and legal consequences.
- The objective of the Amnesty program is to offer relief to exporters who haven't submitted their Authorization during the following period:

(i) Authorizations issued under FTP 2009-14 from 27.08.2009 till 31.03.2015.

(ii) Authorizations issued under FTP 2004-09 and before, wherein the EO period (Original or Extended) are valid beyond 12.08.2013.

· No further extension will be provided by O/o DGFT to file applications under the Amnesty Scheme beyond 31st December, 2023.

· If the concerned exporter fails to file the application under the Amnesty Scheme before the deadline, Show Cause Notices shall be issued.

Members are therefore requested to kindly direct your office who is handling export related matters to check the records of the Advance Authorization and EPCG Scheme for the said FTP period and do the needful Deadline (i.e. 31st December, 2023) to avoid disappointment and penalty.
