<u>Sub: DGFT extends RoDTEP support for exports made by Advance Authorisation</u> (<u>AA) holders, Export Oriented Units (EOU) and Special Economic Zones (SEZ) units</u>

Dear Member,

We are glad to inform you that the Government has extended the RoDTEP Scheme for exports made by Advance Authorisation (AA) holders, Export Oriented Units (EOU) and Special Economic Zones (SEZ) units through DGFT Notification No. 70/2023 dated 8th March, 2024 (enclosed) and Press Release dated 8th March, 2024 issued by Ministry of Commerce & Industry (enclosed). The Council is grateful to the Government for considering our long pending representation.

- (A) Highlights of the Notification:
- -- RoDTEP benefit is extended to <u>AA holders (except Deemed Exports) & EOU units</u> from <u>11th March, 2024 till 30th September, 2024</u> as per <u>Appendix 4RE.</u>
- -- Extension of RoDTEP to <u>SEZ units</u> as per <u>Appendix 4RE</u> will take place on <u>IT integration of SEZs with Customs Automated System (ICEGATE)</u>, which is expected to be operational from <u>1st April</u>, <u>2024 till 30th September</u>, <u>2024</u>.
- -- <u>Revision of RoDTEP rates in 25 HS Codes</u> are also being made in <u>Appendix 4R</u> [Textile items are excluded in this revised list (enclosed)].
- -- RoDTEP scheme has been further extended till 30th September, 2024.
- (B) Following Amendments / deletion / addition of Sr.Nos. under RoDTEP Scheme in FTP 2023 w.e.f. 11.3.2024:
- -- Sr. No. (vii) of Para 4.54 under FTP 2023 has been amended.
- -- <u>Sr. Nos.(viii), (x), (xi) and (xii) of Para 4.55</u> (Ineligible supplies/items/categories under the Scheme) of <u>FTP 2023</u> are <u>deleted w.e.f. 11th March 2024.</u>
- -- A new Para 4.59A has been added under FTP 2023.
