Dear Member,

Mumbai Customs has conducted a special drive from 4th March, 2024 to 18th March, 2024 for cancellation of all the pending Bond/Bank Guarantee on account of submission of Export Obligation Discharge Certificate (EODC)/ Redemption Letters issued by the DGFT Authorities. In this regard, Public Notice No. 51/2024 dated 01.03.2024 has been issued by Mumbai Customs ([enclosed](#)).

Please note that -

-- This drive has been initiated to cancel all the pending Bonds/ Bank Guarantee submitted by the EPCG/ DEEC Licence holders at the time of registration of the Licence in this Zone.

-- During the drive, licences in respect of which EODCs having QR Codes will be closed on the same day of submission of EODC after due verification and an acknowledgement will be given to the exporter.

-- The list of the pending licences as per available records, in respect of EPCG is [enclosed](#).

-- The list of the pending licences as per available records, in respect of DEEC (Advance Authorisation) is [enclosed](#).

-- The Licence holders/Customs Brokers may submit the relevant documents, viz. EODC/Redemption Letters issued by the concerned DGFT in respect of the pending licences to the officers (details annexed to the Public Notice 51/2024 dated 01.03.2024) nominated at CRU (Export) Section, Ground Floor, New Customs House, Mumbai or forward the same on the following email ids of the concerned Sections during 10.30 am to 6.00 pm:

(2) For DEEC: deec.mcell-nch@gov.in
