The Council has received a communication from O/o Textile Commissioner (TxC), Mumbai informing about a study being proposed to evaluate the percentage of wastage of Cotton for fixation of Input Output Norms for the following:

J18 - Bleached or Processed Polyester/ Cotton Blended Fabrics or Made-ups

J34 - Finished Flax Blended Fabrics [Grey or Dyed] containing Polyester/Viscose/Cotton/Flax J43 - Flax Cotton Blended Yarn

J67 - Polyester/Cotton Blended Dyed spun Yarn

J68 - Polyester/Cotton Blended Grey Spun Yarn

187 - Viscose/ Cotton Blended Yarn

J88 - White Ground Brasso printed Saree Mercerised Polyester/Cotton blended

J204 - Made-ups manufactured out of Polyester Cotton Blended Grey & Processed Fabrics

J215 - Socks-Blended [made from cotton, Nylon/Polyester, Dyed Acrylic, Dyed Polyester Elastic Yarn]

J307 - Polyester/Viscose/Cotton Blended Grey/Dyed Yarn
