<u>Sub: Enabling provisions for import of inputs that are subjected to mandatory.</u>
<u>Quality Control Orders (QCOs) by Advance Authorisation holders, EOU and SEZ</u>

Dear Member,

We are glad to inform you that DGFT has issued Public Notice No.10/2024-25 dated 06.06.2024 (copy enclosed) by adding/notifying "Department of Chemicals & Petrochemicals (DGPC)" under Appendix 2Y. This will enable Textile manufacturers to take advantage of this QCO exemption for goods to be utilized/consumed in manufacture of the export product.

As you may be aware, DGFT vide Public Notice No.50/2023 dated 11.03.2024 had included Ministry of Textiles under Appendix 2Y after Council's recommendation. On Council's further request, DGFT has now included Department of Chemicals & Petrochemicals under the said Appendix. The Council is grateful to the Government for considering our representations.

Appendix 2Y relates to List of Ministries/Departments whose notifications on mandatory QCOs, that are exempted by the DGFT for goods to be utilized/consumed in manufacture of export products.

DGFT vide Notification No.16/2024-25 dated 06.06.2024 (<u>copy enclosed</u>) has revised Para 2.03 (A) (i) (g) by adding chemical products along with textiles. Hence, the Notified Ministries under the revised para will be Ministry of Textiles and Department of Chemicals & Petro-chemicals (DCPC).

Please note that the Export Obligation (EO) for these products imported by Advance Authorisation holders, EOUs and SEZs are exempted from mandatory Quality Control Orders (QCOs) of Ministry of Textiles and DCPC and is regulated in terms of para 2.03 (A) (i) (g) of FTP 2023.

Members may kindly make a note of the above.
