Sub: CBIC permits transshipment of Bangladesh export cargo to third countries through Air Cargo Complex at Kempegowda International Airport, Bengaluru

Dear Member,

CBIC vide Circular No.9/2024-Customs dated 9.7.2024 ([copy enclosed](#)) has allowed transshipment of Bangladesh export cargo to third countries through the Air Cargo Complex at Kempegowda International Airport, Bengaluru with effect from 15.7.2024.

As you may be aware, CBIC vide Circular No.29/2020-Customs dated 22.6.2020 allowed transshipment of Bangladesh export cargo to third countries through Kolkata Air Cargo.

Later CBIC vide Circular No.3/2023-Customs dated 7.2.2023 allowed transshipment of Bangladesh export cargo to third countries through Delhi Air Cargo.

Now CBIC has received representations to allow this movement through Air Cargo Complex, Kempegowda International Airport, Bengaluru also, for better cargo evacuation and improved logistics efficiency.

CBIC Circular No. 09/2024-Customs dated 09.07.2024, has been amended by inserting new Para 3B by allowing transshipment of goods by road from LCS Petrapole to Air Cargo Complex, Kempegowda International Airport, Bengaluru with effect from 15.7.2024 following the procedure prescribed in the aforesaid Circular, until further direction from the Board."

Q. How does transshipment of Bangladesh export cargo to third countries through Kolkata Air Cargo and Delhi Air Cargo take place?

Ans: The goods loaded on containers / closed bodied trucks enter India from LCS Petrapole, move by road to Kolkata Air Cargo or Air Cargo Complex, Delhi from where they are airlifted and transported to third countries.

Members may kindly make a note of the above.
