Sub: DGFT extends RoDTEP benefits to DTA units and AA/EOU/SEZ units beyond 30th September, 2024

Dear Member,

We would like to inform you that DGFT has extended RoDTEP benefits for exports made from DTA/AA/EOU & SEZ beyond 30th September, 2024 vide Notification No.32/2024-25 dated 30th September, 2024 ([enclosed](#)).

Please note that –

- RoDTEP Scheme extended for exports made from Domestic Tariff Area (DTA) units till 30th September, 2025.
- Benefits of RoDTEP Scheme available for Advance Authorisation (AA) holders (except Deemed Exports), Export Oriented Units (EOUs) and Special Economic Zones (SEZs) upto 31st December, 2024.
- Revised RoDTEP rates under Appendix 4R (DTA units) ([enclosed](#)) and Appendix 4RE (AA/EoUs/ SEZs) ([enclosed](#)) are being notified for implementation w.e.f. 10th October, 2024, once the ICEGATE portal gets updated with new rates.
- Details of revised RoDTEP rates is available at the DGFT Portal (www.dgft.gov.in) under the link 'Regulations >>> RoDTEP'.
- The revised rates range from 0.3% to 3.9%, lower than the previous bracket of up to 4.3%, aligning with the budgetary allocation of FTP 2023.
- For exports made between 1st October, 2024 and 9th October, 2024, the existing rates as in Notification No. 70/2023 dated 8th March, 2024 ([enclosed](#)) shall continue to apply.
- However, notwithstanding the extension of RoDTEP Scheme provided beyond 30.9.2024 in sub-paras (i) and (ii) above, in order to adhere to the budgetary framework as provided in Para 4.54 of FTP 2023, so that the outgo remains within the approved budget of the scheme, necessary changes shall be made to the scheme benefits, wherever necessary, including revisions or deletions in the eligible RoDTEP export items, rates, per unit value caps and other measures as per Para 4.54 (v), (vi),

(vii) of FTP 2023, as and when required.

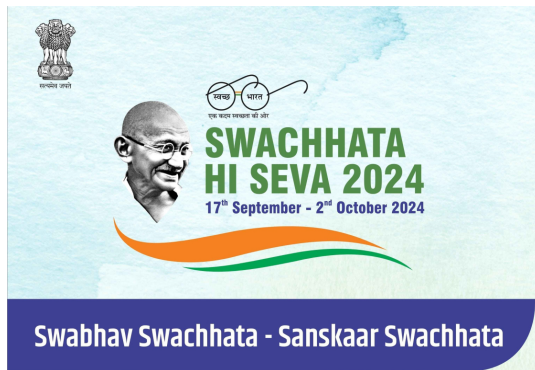
