Sub: Representation for an upward revision of RoDTEP Rates issued vide Notification No. 32/2024-25 dated 30th Sept. 2024 for Cotton Textile products

Dear Member,

Kindly refer to Council's E-Serve No.172 of 2024 dated 1st Oct. 2024 regarding extension of RoDTEP benefits to DTA units (Appendix 4R) and AA/EOU/SEZ units (Appendix 4RE) beyond 30th Sept. 2024 vide DGFT Notification No.32/2024-25 dtd. 30th Sept. 2024 which was made effective from 10th Oct. 2024.

Upon thorough review, it was noticed that the current rates for few of our items are lower than the previous levels. Consequently, we have submitted a request to the RoDTEP Division in New Delhi for aligning the rates more closely with our prior rates in case for Cotton Textile items. The RoDTEP Division has agreed to our request and informed us vide their Office Memorandum dated 9th Oct., 2024 to submit Revised Proformas from members who wish to adjust their RoDTEP Rates.

This is a good opportunity provided by the Division to members who wish to submit the Revised/New Proformas for their products seeking higher RoDTEP rates to enhance export competitiveness.
