-- The program is free of charge and is covered under the funds of the federal budget of the Russian Federation within the quota of the Government of the Russian Federation.

-- The program aims to provide knowledge, skills and competencies in the basics of political, economic, managerial, legal and financial of doing business in Russia to the students from countries that are friendly to Russia.

-- Lectures and Webinars within the program take into consideration peculiarities of the Indian audience and business environment and include materials provided by Indian entrepreneurs who successfully implement business projects in Russia, as well as lectures delivered by representatives of the Russian authorities, corporate sector, think-tanks and consulting organizations.

-- Doing Business in Russia program is delivered in a distant learning mode. The start of classes for the first student group is scheduled for September 2025. The program duration is for 2 months.

-- Doing Business in Russia educational program being offered for the students and

entrepreneurs from the Republic of India will contribute to the development of business relations between Russia and India and strengthen bilateral trade and economic relations.
