Participation Fees

Special discounted price offered by the organisers for exhibitors' participation through TEXPROCIL is Rs. 1, 41,750/- for a 9 sq. mtr shell scheme (Card rate is Rs. 1, 57, 500).

In addition, eligible members can apply to obtain further stall subsidy and air fare under the MAI scheme of Government of India (Only 20 applicants on First- come-First- serve basis).

Kindly note the following regarding your participation:

- Each 9 sq. m of exhibit space includes: Octonorm Panels, 1 Info Desk, 1 Round Table, 3 Chairs, 3 Spot Lights, 1 Fascia Board, 1 Power Socket, 2 Garment Hangers or Wooden Shelves and 1 Waste Bin.
- *Corner booths will be charged extra at 10% of the participation charges (subject to availability). Shell booth 9 sqm. corner booth charges are Rs. 1,55,925/-*
- Participation fees does not include airfare, sending display material and other related expenditure which are to be borne by the companies/exhibitors.

Guidelines for the Allotment of Booths:

1. All the participants who apply and pay the full participation fee on time would be considered for allotment of stall space on FCFS basis (No part payment will be accepted)
2. No change in the stall space, once allotted would be entertained under any circumstances.

Cancellation

In case of cancellation / withdrawal of participation by Members full participation fees will be forfeited.

MAI funding

This is one of the events proposed by Council for receiving support from Ministry of Commerce under MAI Scheme (Awaiting final approval). MAI funding on approval from MoC will be eligible only for the first 20 companies applying for the participation with the completed application form and full payment to avail the MAI benefit on a

First Come First Served basis. Since the official approval from Ministry of Commerce is still awaited, we are presently charging the full amount as being charged by the organizers i.e. Rs. 1,41,750. On receipt of the approval from MoC, the Council shall accordingly arrange to reimburse the subsidy amount applicable under MAI to the first 20 eligible participants subject to the following important criteria.
