Further to our circular dated 9th April 2025 for Texworld Evolution, we have been informed by the Organizers Messe Frankfurt Paris that in addition to the Fabrics and Apparel sourcing pavilion, space is also available at the YARN EXPO PAVILION in the Show.

The Cotton Textiles Export Promotion Council is organizing National Level Participation in 'Texworld Evolution' held at Paris Le Bourget, France from 15th to 17th September 2025 and is already mobilizing participants for the fabrics and apparel sourcing pavilions.

This is one of the events proposed by Council for receiving support from Ministry of Commerce under MAI Scheme and awaiting the Ministry's approval. On approval from Ministry of Commerce, the MAI subsidy will be eligible only for the first 20 companies applying for the participation with the completed application form and full payment to avail the MAI benefit on a First Come First Served basis. Please note that this fee does not include airfare, hotel expenditure, sending display material and other related expenditure. MAI grant will not be available.

Corner Booth Premium

Actual fees charged by the organizers will be applicable for corner booth premium i.e. discount / subsidy is not applicable for corner booth premium.

Due to availability of limited number of corner booths, allocation will be done by Messe Frankfurt, Paris, after considering various aspects as per their own guidelines.
