## <u>Sub: Virtual B2B Meeting with Colombian Buyers - November 13, 2025</u>

#### Dear Member,

We are pleased to inform you that TEXPROCIL, in association with the Embassy of India in Colombia, the Bucaramanga Chamber of Commerce, the Colombia–India Chamber of Commerce, and Conexiones B2B, is organizing a **Virtual B2B (Buyer-Seller) Meeting on November 13, 2025 (Thursday) from 7:30 PM to 10:30 PM IST** (9:00 AM to 12:00 PM COT).

The objective of this session is to connect Indian exporters with Colombian importers in the textile sector, particularly in the following product categories:

- Silk (Chapter 50): 5007 Silk fabrics
- Cotton (Chapter 52): 5201 Uncarded and uncombed cotton; 5204 Cotton sewing threads; 5205 Cotton yarns; 5208 & 5209 Cotton fabrics
- Yarns and Threads (Various Chapters): 5307 Jute yarns; 5403 Artificial filament yarns; 5509 Synthetic fiber yarns; 5605 Metalized yarns

Approximately **20 Colombian companies** are expected to participate in this Virtual B2B session.

### About the B2B event:

- **1. Export Opportunity Platform**: TEXPROCIL is facilitating this exclusive business networking opportunity in collaboration with the above-mentioned organizations to help Indian exporters explore the Colombian textile market.
- **2. Selection & Scheduling:** The importing companies from Bucaramanga will select the Indian participants based on their business interests. TEXPROCIL will not be involved in the matchmaking or scheduling of meetings.
- **3. Participation Charges:** Each participating Indian company will be required to pay **Rs. 10,000 plus GST** towards facilitation and service charges for each business meeting scheduled.

#### **Key Details of the B2B Sessions:**

1. Each B2B meeting will have a duration of 30 minutes.

- 2. Matchmaking: Private Zoom Breakout Rooms for each meeting will be organized.
- 3. These will be based on a pre-arranged Matchmaking Agenda that will be sent to all participants 2 days in advance.
- 4. Notifications: A 5-minute warning notification will be sent before the end of each meeting.
- 5. Test: A preliminary meeting may be organized two days prior to the event (11th November 2025 to explain the process and test the systems.
