Sub: Submission of Data for RoDTEP and RoSCTL – 2025 for MOOWR Units Last Date: 5th January 2026 (Monday).

Dear Member,

The Council sincerely thanks all members who have already submitted the RoDTEP and RoSCTL data for 2025 and appreciates their timely cooperation.

Members are hereby informed that the RoDTEP Committee has requested separate and specific data in respect of exports made under MOOWR Units (Manufacturing and Other Operations in Warehouse Regulations) ([letter enclosed](#)).

MOOWR – In brief:

- Customs-bonded manufacturing scheme
- Allows import of raw materials and capital goods without immediate customs duty
- Manufacturing/approved operations permitted in bonded warehouses
- Duty payable only on domestic clearances
- No duty on exports
- No mandatory export obligation

□ In short, it allows manufacturers to delay customs duty payment and improve cash flow, while freely manufacturing inside a bonded warehouse.

Accordingly, members operating under MOOWR Units are requested to submit the relevant RoDTEP and/or RoSCTL data for the export period 01.04.2024 to 31.03.2025 in the prescribed formats.

Submission Guidelines:

- Data to be certified by Manufacturer and Chartered/Cost Accountant
- Supported by relevant documents (tax invoices, shipping bills, state levies, etc.)
- Submit Excel file + certified PDF copies
- Separate format for each HS Code

- Do not alter prescribed formats
- Additional information may be provided separately (in Notes)
- No extension will be granted by the RoDTEP Committee

Members may send the completed data by 5th January 2026 (Monday) to ([sybil@texprocil.org](mailto:sybil@texprocil.org) / [annie@texprocil.org](mailto:annie@texprocil.org)) to enable review and onward submission within the stipulated timeline.
