Sub.: Request for Data for the new scheme RODTEP

Dear Member,

As you are aware, the Government propose to introduce a new Scheme for Remission of Duties & Taxes on Exported Products (RODTEP). The Government has started its exercise of working out of the details of the scheme including the rates and value caps.

In this regard, the office of DGFT has sought data and recommendations from the Council. The data will be examined by the Sectoral RoDTEP Committees (SRC) in DGFT headquarters.

We would request you to please send us the data in the prescribed formats (R1, R2 and R3) which are enclosed herewith [\(click here\)](#).

In this regard, please note the following:

- (1) The details should be provided for the export products HS code wise.
- (2) Data provided should mandatorily be based on the exports made during the period **January to June 2019**.
- (3) Data provided should be certified by a **Chartered Accountant / Cost Accountant**.
- (4) The data should be supported by relevant documents such as Shipping Bills, Bill of

Entry, Mandi Tax rate circular, Electricity Duty circular of the respective state along with proper justifications.
