The Cotton Textiles Export Promotion Council (TEXPROCIL) jointly with Apparel Export Promotion Council proposes to organize **Buyer Seller Meet (B2B meetings) in Santiago, Chile and Montevideo, Uruguay from 25th to 29th March, 2019 with 25 exhibitors** at each venue. Ministry of Textiles & Ministry of Commerce has approved funding under **Market Access Initiative (MAI)** for the BSM - Chile & Uruguay.

The B2B meeting dates and venue are given here under:-

SANTIAGO, CHILE:-

- **Set up & Move-in day : 24th March, 2019 (Sunday)**
- **BSM Days : 25th & 26th March, 2019 (Monday & Tuesday)**
- **Transit to Montevideo from Santiago, Chile : 27th March, 2019 (Wednesday)**

MONTEVIDEO, URUGUAY:-

- **Set up & Move-in day : 27th March, 2019 (Wednesday)**
- **BSM Days : 28th & 29th March, 2019 (Thursday & Friday)**

Participation Fee:

After financial support of Ministry of Commerce under MAI, the participation charges are as follows:

1. Booth of approx. 9 SQM: Rs.1,10,000/- + 18% GST = **Rs.1,29,800/-**
2. Early Bird Discount Rs 10,000
(If payment is made on or before 31st December, 2018) Rs. 1,00,000/- + 18% GST = **Rs.1,18,000/-**
3. If payment received After 31st Dec., 2018 Rs.1,10,000/-+ 18% GST = **Rs.1,29,800/-**
4. Participation charges without MAI Rs. 1,90,000/- + 18% GST = **Rs.2,24,200/-**
