**Sub : Request for data for the RODTEP scheme**

**Dear Member,**

As you are aware, the Government has approved the Scheme for "Remission of Duties and Taxes on Exported Products (RoDTEP)". The scheme will refund certain taxes /duties/levies that are outside the purview of GST and are not refunded for exports such as VAT on fuel used in transportation, Mandi tax, Duty on electricity used during manufacturing etc.

In this regard, the Government has constituted a Committee consisting of the following members to determine the ceiling rates under the RODTEP scheme:

- (1) Shri G.K.Pillai, Secretary (Retired), Government of India, Chairman
- (2) Shri Y.G.Parnade, Special Secretary –Cum- Member, CBEC (Retired) – Member
- (3) Shru Gautam Ray, Chief Commissioner of Customs and Central Excise (Retired) – Member.

The Committee has started the exercise of determination of ceiling rates under the RODTEP scheme.

The Central Board of Indirect Taxes and Customs (Drawback Division) has sought

data from the Council on inputs used in the export products.

You are requested to please send us the data in the prescribed format i.e Proforma- R1, R2 and R3 on the email IDs [ravikumar@texprocil.org](mailto:ravikumar@texprocil.org) / [vimal@texprocil.org](mailto:vimal@texprocil.org) **positively on or before August 21, 2020.**

Please note that the data should be related to exports made during the period from 01.10.2019 to 31.03.2020.

You are requested to please go through the above and do the needful.
