Sub : Meeting on the RODTEP scheme - August 20, 2020 (Thursday)

## Dear Member,

The Council will be holding a Meeting of exporters through video conferencing on **August 20, 2020 (Thursday)**. Separate meetings will be held to discuss on Cotton Yarn, Fabrics and Made ups.

As you are aware, the Government has approved the Scheme for "Remission of Duties and Taxes on Exported Products (RoDTEP)". Further, the MEIS scheme will be discontinued after the implementation of the RODTEP scheme. The Government has constituted a Committee to determine the rates for different export products under the RODTEP scheme.

In this regard, the Government has sought data from the Council on the duties and taxes on the inputs used in the export products for the fixation of rates under the RODTEP scheme.

In order to submit detailed proposal to the Government and also to recommend the rates for different Cotton textiles products under the RODTEP scheme, the Council will require data and documents from its members.

The objective of the meeting is to explain about the RODTEP scheme and its

benefits, the tax/ duty incidence on the export products, concept of embedded taxes, calculation of the rates etc. and also to guide the members to provide data to the Council in the prescribed format i.e Proforma- R1, R2 and R3 – Copies of the formats are enclosed herewith <u>(click here)</u>.

We would request you to please attend the meeting.
